

Why it Matters



All EU-based companies with a 500+ headcount will be required to make CSR disclosures starting from 2017 onwards



Sustainability services market is expected to “explode”: up to 15,000 CSR reports for 2017 vs. 2,000 reports in 2014-2015

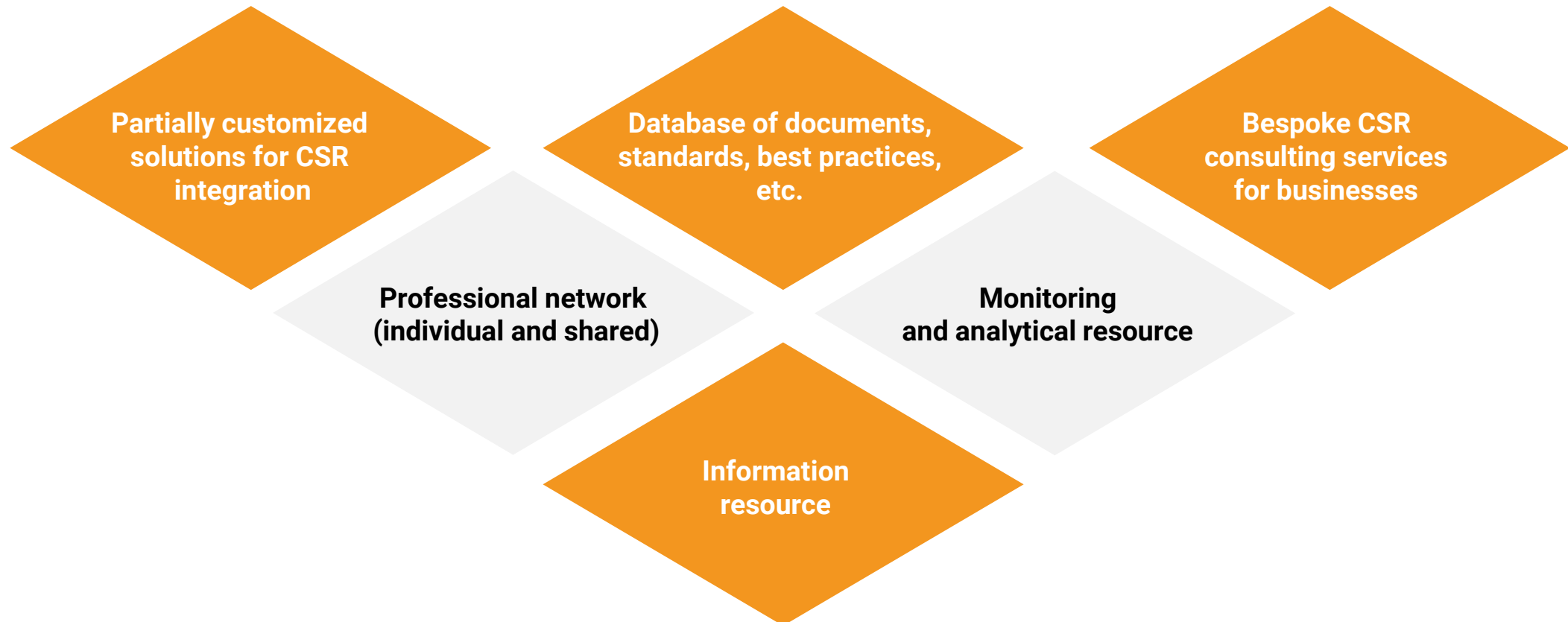

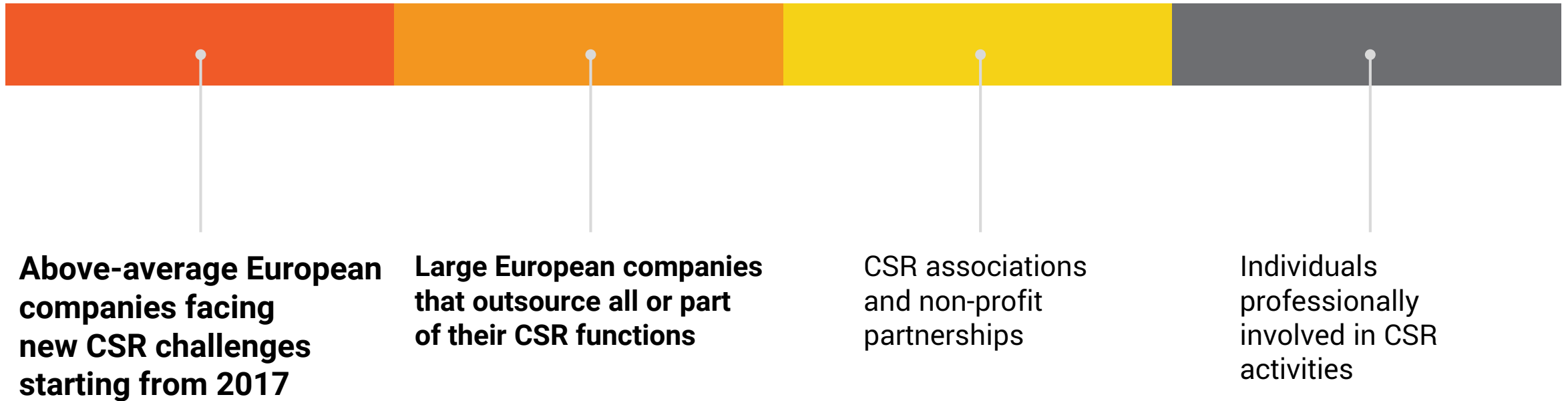

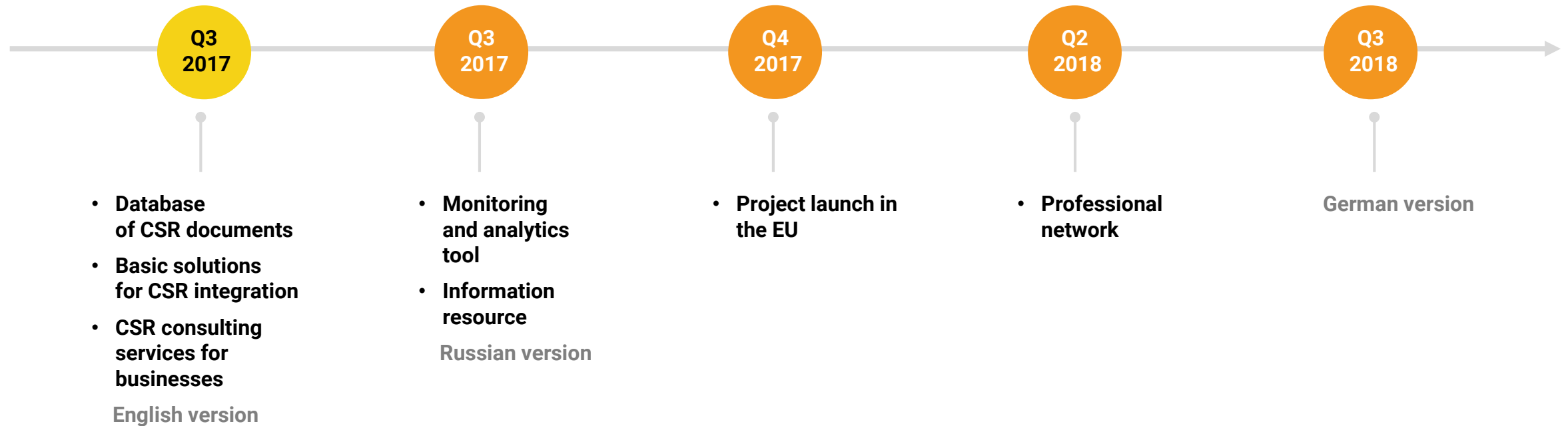

Platform Services Launch Timeline





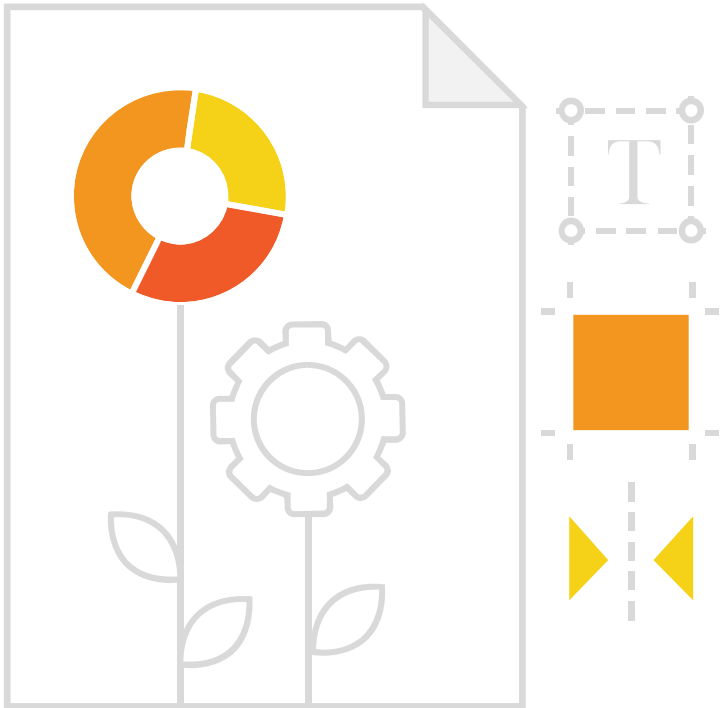

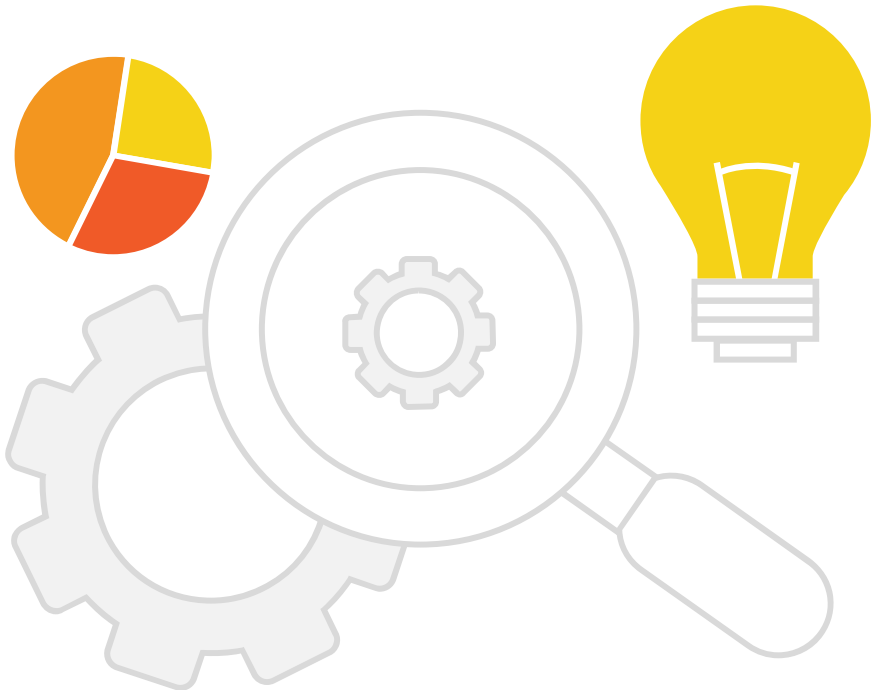

Low Cost and Service Selection Function

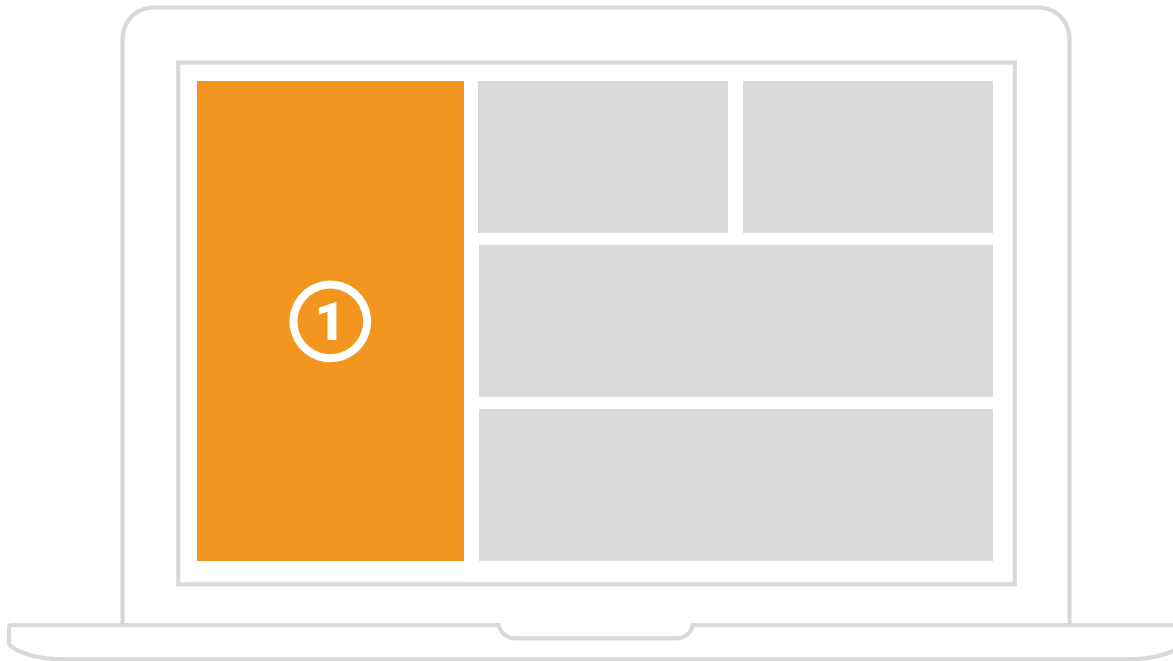


- Ability to select the entire range of services – from data mining to report generation – all for a fee of no more than €2,000 per year

- Free trial period for new customers



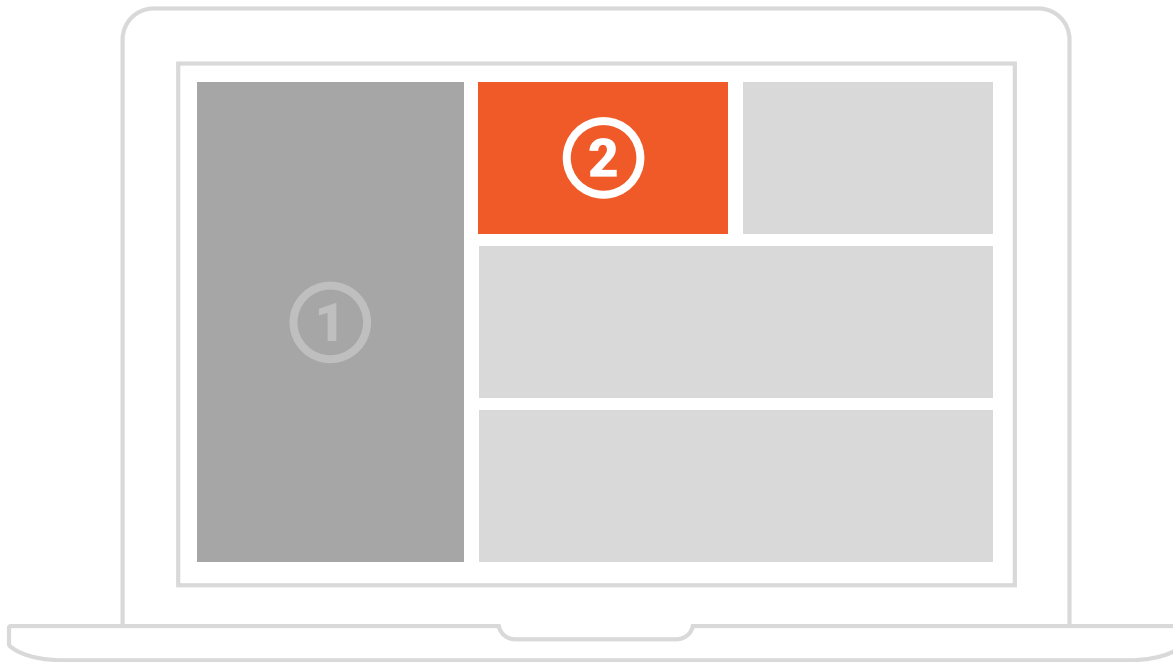

CSR Integration Solutions (fee-based function)



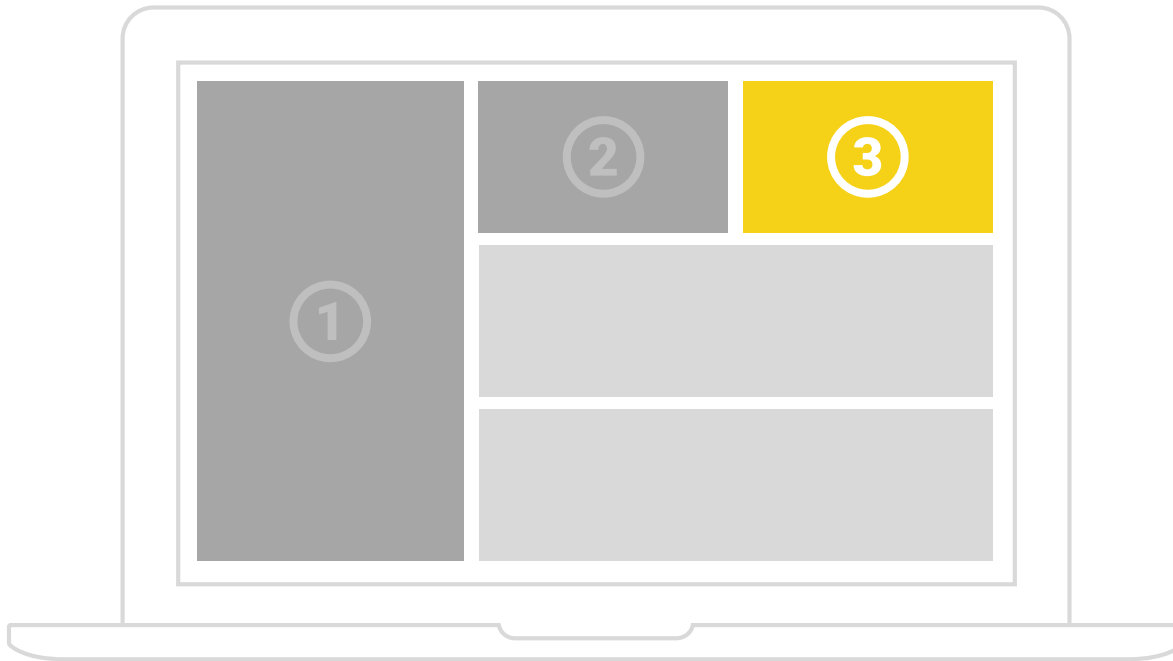
- 'Entry' questionnaire for companies

Monitoring and Analytics (mostly fee-based function)



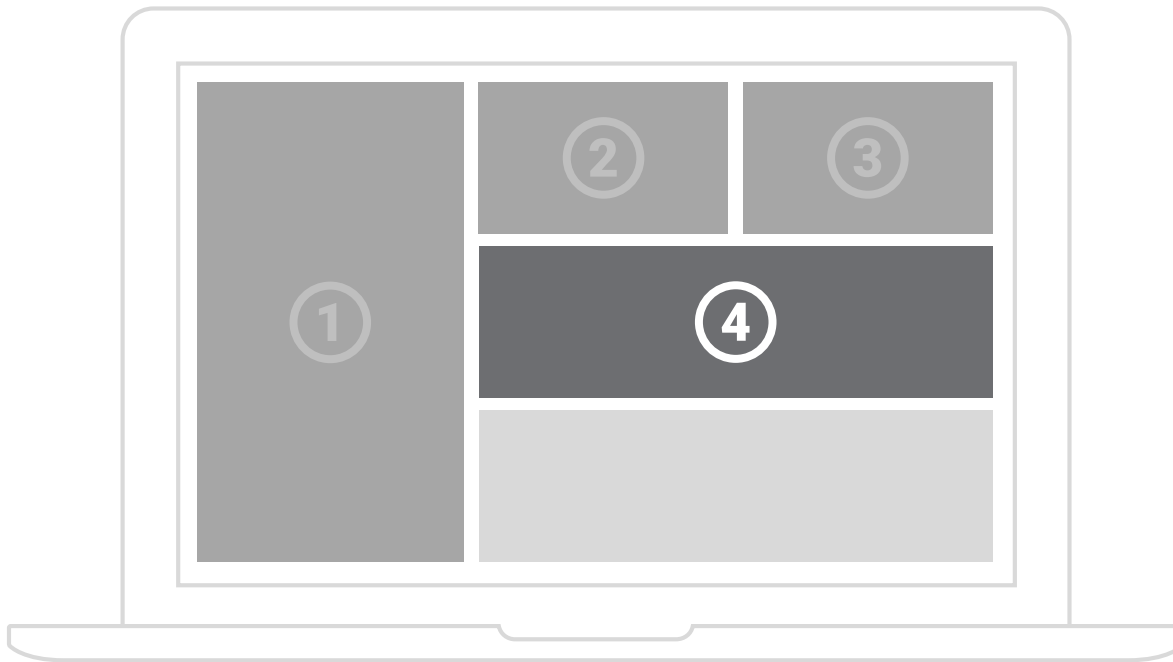

News Content



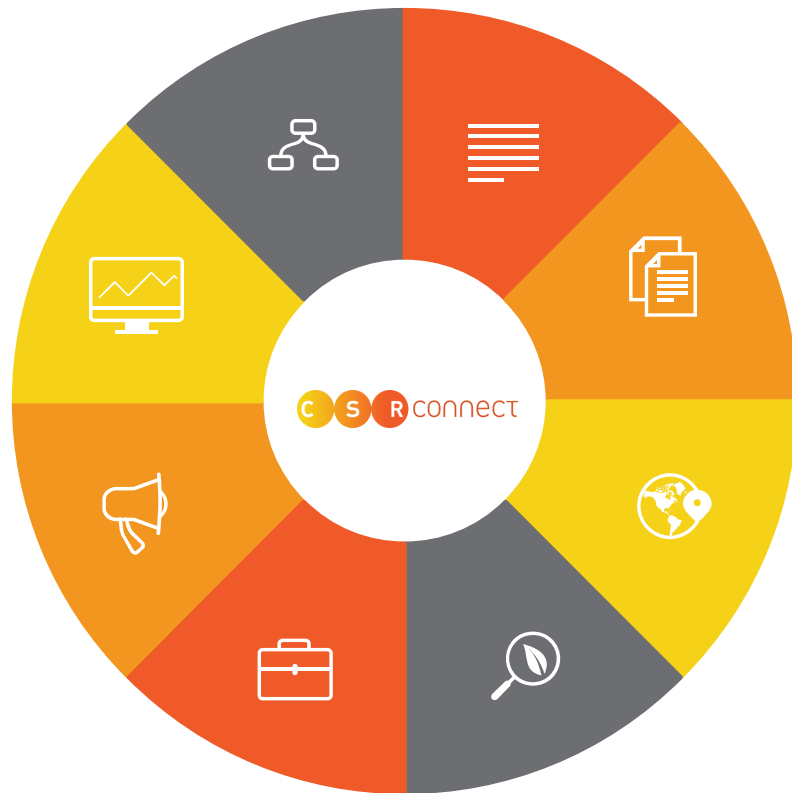
